

Symposium 2024 Terms and Conditions SympoCee March 21, 2024

Article 1. Definitions

In these Terms and Conditions the following definitions hold:

- a) Cover: Study Association Cover
- **b)** SympoCee: The committee of Cover responsible for organizing the Symposium.
- **c)** The Symposium: The Symposium that will take place on the 24th of April, organized by the SympoCee.
- **d)** Participation fee: The costs of registration, services and facilities offered on the day of the Symposium.
- e) Participant: Person who has registered for the Symposium.

Article 2. Applicability

- **a)** These terms and conditions are applicable to all participants of the Symposium of Cover, organized by the SympoCee.
- **b)** Deviations from and additions to these terms and conditions are valid if and only if these are made known on the website of the SympoCee, or when they are explicitly agreed upon in writing.

Article 3. Data

- **a**) The Symposium guarantees the correctness, completeness and reliability of the information she provides.
- **b)** In case of a dispute, the information published on the website of the SympoCee will be used as a starting point.
- **c)** The content of the Symposium is determined by the information as published by the SympoCee on the website, or other publications of the SympoCee. The SympoCee is not bound by any manifested errors or mistakes. The SympoCee cannot be held responsible for any content provided by third parties.
- **d)** The SympoCee will treat the data, provided by the participant on the registration form, in a confidential manner according to Cover's privacy statement¹.

Article 4. Registration

- **a**) The agreement between the SympoCee, Cover and the participant is established through registration on the website.
- b) The registration period is open from the 25th of March 12:00, 2024.
- c) Registration is completed when a confirmation has been received.
- **d)** Registration obliges the participant to pay the participation fee. For further provisions on cancellation, see article 7.
- e) During the registration, the participant is able to provide preferences with respect to the services and facilities provided by the SympoCee. The SympoCee will care to take these preferences into account as much as possible. No rights can be derived from this.
- **f)** The final deadline of registration will the 23th of April 2024 at 23:59. When we reach the maximum capacity of 100, tickets will also no longer be available.
- **g)** The SympoCee, in consultation with the board of Cover, retains the right to, without giving reasons, provide (or deny) people the right to participate in the Symposium.
- h) In case of misconduct before or during the Symposium, the SympoCee, in consultation with the board of Cover, is entitled to exclude the concerning participant(s) from further participation of the Symposium. The participant(s) will still be obliged to pay the participation fee to Cover.

Article 5. Payment

- a) For the members of the study association Cover, the following applies:
 - (i) The first 20 Cover members who buy a ticket are eligible to purchase an early bird ticket for 9,50€ via the Symposium's website.
 - (ii) Cover members are eligible to purchase a Cover member ticket for 12,50€ via the Symposium website.
 - (iii) The ticket prices above exclude the payment processing costs.
- **b**) For Staff members of the University of Groningen the following applies:
 - (i) Cover members are eligible to purchase a Cover member ticket for 12,50€ via the Symposium website.
 - (ii) The ticket prices above exclude the payment processing costs.
- c) For non-members of the study association Cover, the following holds:
 - (i) Non-members of Cover are eligible to purchase a non-Cover member ticket at the price of 22,50€ via the Symposium's website.
 - (ii) The ticket prices above exclude the payment processing costs.

Article 6. Cancellation

a) Cancellation of registration by the participant can only occur in writing, with reasoning.



- **b)** In case of cancellation, the participant is still obliged to pay the participation fee, barring special exceptions to be reviewed by the SympoCee. No refunds will be given.
- **c)** Short-term cancellation due to unforeseen circumstances does not remove any obligations from the participant to, after the deadline of registration, pay the participation fee.
- **d)** Tickets are only transferable when approved by the SympoCee. The person to whom the ticket is transferred should be eligible for the same kind of ticket that was purchased.

Article 7. Accountability

- a) The accountability of the SympoCee is limited to which is agreed in these terms and conditions.
- b) The SympoCee is not accountable for any damage that is the result of:
 - (i) Shortcomings in the implementation of the agreement based on conditions which are attributable to the participant, including damage as a result of health conditions of the participant.
 - (ii) Actions and influences of third parties.
 - (iii) Conditions which are not due to the fault of the SympoCee and/or, under the law or standards in social interaction, cannot be reasonably attributed to the SympoCee.
- c) The SympoCee is not accountable for any damage of the participant due to incorrect or incomplete information provided by the SympoCee to the participant.
- **d)** The SympoCee is not accountable for any indirect or consequential damage as a result of actions of the participant. Damages caused by the participant leading to costs will be charged to the participant, under the law or standards of social interaction.
